Finances continue to trouble Ravenna

The Ravenna City Council met on Tuesday, October 14, 2013 and after reviewing the monthly budget there were still a lot of questions and concerns about the new format that is being used by the city clerk.

According to city clerk Susan Lay, the balance was \$831.21 on September 30th, but the new spread sheet does not show beginning and ending balances which is something that council members have asked to see on the report.

"How are we supposed to know how much is in there if it's not on the report?" asked Louis Officer.

A question was also raised about a \$400 transfer from the Railroad Festival account to the general fund. Mayor Estine Tipton said that it was needed to pay bills with last month, therefore, the money was transferred into the account.

William VanCleve stated that he still didn't understand the new format that was being used for the financial report and asked if each council member could have an itemized report at each monthly meeting.

Mayor Tipton said that due to the cost of ink and paper she thought it was too expensive to print out that many copies each month but the council members were more than welcome to see the copy that City Clerk Susan Lay had.

Louis Officer said that he had a complaint about children playing on the memorial at the park. He said he thought it was garbage that children were playing on the memorial but their parents were allowing it to happen. He said that it cost around \$50 to have a brick put back into the memorial wall and VanCleve said that he didn't

Small amounts of marijuana was found last week in some Madison County Schools by the Irvine Police Department's drug dog.
