Rules:

4-H premiums are listed as a total. The premium will be divided among participants in each class to help make prize money more equal for large classes and small classes. In case of a small number of entries, the prize will not be excessive. Ribbons will have a value for computing the prize - Blue 3X, Red 2X, and White 1X.

•The exhibitor is to furnish pens/cages and necessary care for animals during the entire time they remain on grounds. Exhibitor is responsible for waste control.

•The ribbons will be awarded champion, blue, red, and white in each class.

•Must be an animal that you have taken care of.

•4-H'ers must show their own rabbits or another 4-H'er may show a rabbit for them. 4-H'ers must bring rabbits to the show table.

•Only one (1) entry per class allowed.

•Exhibitors will complete a judges' remark card for all entries at time of registration. No changes after the show starts.

•Health forms are not necessary but animals showing symptoms of disease or illness will be guarantined and not allowed to show. •No does with litters accepted.

•All rabbits must be permanently tattooed. Rabbits will be disqualified if they are not permanently marked. Rabbits will be disqualified if there is more than one identification tattoo in the left ear.

•Any breed not having at least five (5) entries at the time of the show will be placed in the All Other class for the show.

• Rabbit showmanship will be shown under Kentucky 4-H Guidelines, please see your Estill County Extension Agent for 4-H Youth Development.
