

# Grand jury returns 30 indictments

Officer Marshall was the investigating officer.

An indictment was returned against Henry Coffey, 40, of Crooked Creek Road, Irvine on charges of operating on a suspended/revoked license, excessive windshield tint, inadequate silencer, trafficking in a controlled substance, first degree, first offense (methamphetamine), trafficking in a controlled substance (drug unspecified), possession of a controlled substance, drug unspecified, and persistent felony offender, second degree.

The charges were the result of a traffic stop on Coffey January 24 by Officer Marshall. The indictment states that Coffey had 2.889 grams of methamphetamine, gabapentin, and buprenorphine in his possession.

Danny Rose, 47, of Traylor Road, Irvine was indicted on charges of public intoxication of a controlled substance (excludes alcohol), drug paraphernalia -- buy/possess, and possession of a controlled substance first degree and first offense (hydrocodone).

Sheriff Chris Flynn was the investigating officer. Deputy Brad Smith served the Estill Circuit Court warrant on arrest on Rose on July 14.

Candix Johnson, 32, of Stacy Lane, Irvine, was indicted on charges of failure to or improper signal, improper equipment, possession of a controlled substance, first offense (methamphetamine), and drug paraphernalia -- buy/possess.

IPD Sgt. Stuart Morris had made the traffic stop on Johnson on January 21.

The indictment says she had methamphetamine and a digital scale with residue in her possession.

Cody Norton's indictment charges him with possession of a controlled substance, first degree and first offense and operating on a suspended/revoked operators license.

The indictment against Norton, 26, of Stacy Lane, Irvine was the result of a traffic stop on July 26, 2020 by Deputy Josh King. It states that Norton had fentanyl in his possession.

Sheriff Flynn served an indictment warrant on Norton.

Johnathan Dixon, 30, was indicted for fleeing or evading police, first degree (on foot), possession of a controlled substance, first degree and first offense (drug unspecified), possession of a controlled substance, first degree and first offense (methamphetamine), and first degree persistent felony offender.

The indictment says that on January 26, Dixon had fentanyl and methamphetamine in his possession.

Trooper Robinson was the investigating officer.

An indictment charges Owen Woolery, 59, of Woolery Lane, Ravenna with trafficking in a controlled substance, first offense, trafficking in a controlled substance, first degree and first offense (methamphetamine), drug paraphernalia -- buy/possess, and resisting arrest.

Trooper Robinson, the arresting officer, reported that Woolery had 1.539 grams of fentanyl, .250 grams of methamphetamine, a glass pipe and several cut straws in his possession on January 20.

Deputy King served the indictment warrant July 15 on Woolery.

Jessie Rice, 52, of Pea Ridge Road, Irvine was named in an indictment on charges of possession of a controlled substance, first degree and first offense (methamphetamine), and possession of a controlled substance, first degree and first offense (drug unspecified).

The indictment states that Rice had methamphetamine and fentanyl in his possession on August 11.

The investigation was conducted by Trooper Robinson.

Scott Fox, 30, of Highway 52W, Irvine was indicted on a single charge of possession of a controlled substance, first degree and first offense (methamphetamine).

The arresting officer, IPD Officer said Fox had the methamphetamine on September 30.

Hobert Hall, 43, of Autumn Court, Irvine was also indicted on a single charge of possession of a controlled substance, first degree and first offense (methamphetamine).

Officer Conrad reported that Hall possessed the methamphetamine on April 29, 2020.

An indictment charges David McIntosh, 38, of Grace Chapel Road, Irvine with possession of a firearm by a convicted felon.

KSP Trooper Jansen Hacker reported to the grand jury that McIntosh had a firearm on November 30.

Charles Durham, 42, of Richmond Road, Irvine was indicted for trafficking in a controlled substance, first degree and first offense (methamphetamine) and being a first degree persistent felony offender.

Deputy Smith said that Durham had 17.069 grams of methamphetamine in his possession on January 27 with the intent to sell.

Kenneth Estes, 35, of Crooked Creek Road, Irvine was indicted for wanton endangerment first degree and criminal mischief first degree.

The indictment says that on May 7, Estes engaged in conduct which created a substantial danger of death or serious physical injury to Debra Rose. It adds that on the same date, he intentionally damaged a Volkswagen belonging to Rose.

Sheriff Flynn conducted the investigation.

Bailiff Carroll served the indictment warrant July 15 on Estes.

Barry Crouch, 43, of John Rawlins Road, Irvine was indicted for strangulation, first degree, criminal mischief third degree, and persistent felony offender, second degree.

The indictment states that on March 26, Crouch intentionally impeded the normal breathing of Wendi Winkler by applying pressure to her throat with his hands.

It adds that he also wantonly destroyed the window visor of Winkler's truck.

Sgt. Stuart Morris conducted the investigation.

Eric McElroy, 45, of McKee Road, Irvine was indicted on a single charge of possession of a controlled substance, first degree and first offense.

The indictment states McElroy possessed methamphetamine on October 17.

Sgt. Morris also conducted this investigation.

A single charge indictment was returned against Heather Jones, 34, of New Fox Road, Irvine.

The indictment is possession of a controlled substance, first degree and first offense.

The arresting officer, Deputy Smith, told the grand jury that Jones had methamphetamine on August 26.

Bailiff Carroll served an indictment warrant on Jones on July 15.

Jeremy Edmonson, 30, of McKee, was indicted for possession of a controlled substance, first degree and first offense.

The indictment states that Edmonson had heroin on June 29, 2020.

Deputy Smith was the arresting officer.

David Flynn, 26, of White Oak Road, Irvine was indicted for possession of a controlled substance, first degree and first offense (methamphetamine).

The indictment states he had the meth on March 29.

IPD Officer Russell Morris was the investigating officer.

Bailiff Carroll served the indictment warrant on Flynn.

Jessica Dargavell, 34, of Winchester was indicted for possession of a controlled substance, first degree and first offense.

The indictment says she possessed methamphetamine on July 2, 2020.

Trooper Carl Roark was the arresting officer.

An indictment was returned against Jerry Richardson, 57, of McKee Road, Irvine. It charges Richardson with trafficking in a controlled substance, first

degree and first offense and possession of marijuana.

The indictment says that Richardson possessed 90 30mg oxycodone pills and marijuana on March 18.

Irvine Det. Sam Hensley conducted the investigation.

Alexander Ramos, 37, of Dry Branch Road, Irvine was indicted for rape first degree - victim under 12 years of age.

The indictment states that about April 2012, Ramos engaged in sexual intercourse with a female who was incapable of consent because she was less than 12 years old.

The investigating officer was Trooper Hacker.

Justin Gerber, 44, of Covey Road, Irvine was indicted on ten charges as the result of a traffic stop February 13 by Trooper Hacker.

The indictment charges Gerber with failure to wear seat belts, no registration receipt, no registration plates, improper display of registration plates, failure to produce insurance card, driving on a suspended license -- second offense, operating motor vehicle under the influence of alcohol, fourth offense or greater, reckless driving, failure to notify address change to Dept. of Transportation, and first degree persistent felony offender.

Danny Bustle, 52, of Berea was indicted on two counts of possession of a controlled substance, first degree and first offense, giving officer false identifying information, and drug paraphernalia -- buy/possess.

The indictment states that Bustle had heroin, fentanyl, and a syringe in his possession on April 17, 2020.

The investigating officer was Deputy King.

Mistie Combs, 45, of Richmond Road, Irvine was named in a nine-count indictment.

She was indicted on two charges of trafficking in a controlled substance, first offense, trafficking in a controlled substance, first degree and first offense (methamphetamine), unlawful transaction with a minor, wanton endangerment first degree, tampering with physical evidence, possession of marijuana, drug paraphernalia -- buy/possess, and first degree persistent felony offender.

The indictment says on Oct. 20 she had fentanyl, heroin, and 56.5 grams of methamphetamine in her possession with the intent to sell.

It adds that she placed the illegal substances in the robe of her daughter who is less than 16 years of age while engaging in conduct which created substantial death or serious physical injury to her children.

It further states that she concealed evidence and had several needles in her possession.

Daniel Conrad, 35, of Pea Ridge Road, Irvine was indicted following a traffic stop on February 16 by Trooper Robinson.

The indictment charges Conrad with operating a motor vehicle under the influence, first offense, operating on suspended or revoked operator license, fleeing or evading police, second degree (on foot), possession of a controlled substance, first degree and first offense (methamphetamine), possession of a controlled substance, second degree (drug unspecified), drug paraphernalia -- buy/possess, no tail lamps, and excessive windshield/window tinting.

According to the indictment, Conrad had suboxone and two syringes.

Zackery Jones, 27, of Winchester Road, Irvine was indicted on ten charges resulting from a traffic stop May 12 by Irvine Officer Jason Conrad.

Those charges include wanton endangerment, first degree, of a police officer, speeding 26 mph or over speed limit, fleeing or evading police, first degree (motor vehicle), disregarding a stop sign, fleeing or evading police, first degree (on foot), driving on a DUI suspended license, third offense, wanton endangerment, first degree, unauthorized use of motor vehicle, first offense, and possession of a controlled substance, third degree and first offense (gabapentin).

Jacob Turpin, 24 of Pea Ridge Road, Irvine and Jeffery Harrison, 39, of Lexington were named as co-defendants in an indictment.

Both men were indicted on charges of drug paraphernalia -- buy/possess, wanton endangerment, and possession of a controlled substance, first degree and first offense (heroin).

The indictment states they had numerous needles and two pop cans with residue on them on November 23. It adds they created a substantial danger of death or serious physical injury to two children present in the home.

Turpin was also charged by the indictment with trafficking in a controlled substance, first offense (heroin) and possession of marijuana.

Harrison was indicted for possession of a firearm by a convicted felon and being a first degree persistent felony offender.

The investigation was conducted by Trooper Hacker. Bailiff Carroll served the indictment warrant on Jones.

Farrell Marcum, 57, of Marcum Road, Irvine and Deanna Leaf, 57, of McKee were named as co-defendants in an 11 count indictment.

Both were indicted on charges of trafficking in a controlled substance, second degree and first offense (greater than or equal to 20 dosage units) and drug paraphernalia -- buy/possess.

The indictment states they had 20 xanax bars, a set of digital scales and multiple packages of small plastic bags on March 29.

Marcum was indicted for assault first degree, two counts of wanton endangerment, second degree, possession of a handgun by a convicted felon, being a first degree persistent felony offender, complicity to aggravated trafficking in a controlled substance, greater than 28 grams fentanyl, (32 grams) and complicity to trafficking in a controlled substance, first degree and first offense (13 grams of methamphetamine).

The indictment states that he intentionally shot Lester Turner in the leg on March 29. It adds that he also created a substantial danger of death or serious physical injury to Ryan Cox and Charles Mason.

Leaf was indicted for aggravated trafficking in a controlled substance, greater or equal to 28 grams fentanyl (32 grams), and trafficking in a controlled substance, first degree and first offense (greater than or equal to two grams methamphetamine). According to the indictment, Leaf had 13 grams of methamphetamine.

Deputy Kevin Shackelford and Sheriff Flynn investigated the case.

Two reports of no indictments were also returned by the Estill County Grand Jury on July 6.

The report dismissed charges against Travis McIntosh, 25, homeless which had been brought to the grand jury by IPD Officer Jim Marshall.

A separate report dismissed charges against Kristopher Estes, 27, of Church Street, Irvine. Estes' charges were made by Trooper Jansen Hacker to the grand jury and were dismissed.

**Jeremiah Hix**, 41, of White Oak Road,

Irvine was served with a bench warrant for Estill District Court on July 16 by Sheriff Flynn.

**Johnathan Barrett**, 34, of Watson Ridge Road, Ravenna was arrested July 17 by Sgt. Morris. Barrett was charged with operating a motor vehicle under the influence and operating on a suspended or revoked operator license.
