




Flattered, Sarah continues her vigil while he drifts back to sleep. Later he wakes up and says, "You're cute."

Coyotes can be found in most of the United States, Canada and Central America. They are a bit smaller than a medium sized dog and have characteristics that set them apart from wolves and dogs. Their fur is gray to tan color and they have bushy tails. They have triangle shaped ears and a narrow, longer nose. A coyote has yellow eyes and a black nose that you can tell them apart from wolves or dogs. When a coyote runs, it runs with the tail in downward position. A wolf for example runs with the tail straight out a dog runs with the tail held high.

Whatever their reason I don't want them near me or my home; you never know when they might be rabid or turn on you.


