#### Righteous Anger by BOB CASEY, preacher Cornerstone Church of Christ **Bond Street at Camp Avenue in West Irvine**

Is it ever a good thing to become angry? Can you take a look at some things that are taking place all around us and be able to hold back his anger? Does not the word teach us in Ephesians 4:26, "Be ye angry and sin not?" So then, is it okay to be angry at people or situations any time? We only have to look into the Bible for our answers. I ask, was our Lord angry when he said to those in the temple that had set up a yard sale event, a livestock yards, and those that practiced the banking trades. Was he angry when he platted a small whip (scourge) and drove them all out? Yes, indeed, he was angry. Makes me wonder if perhaps our buildings of worship need some of these practices today. We can read all about this event in Mark 11:15-17 and John 2:13-17. Read it for yourselves.

My question is: was his anger justified? Again, are you ever angered over a false religious teaching? If your enemy fails to convert to your religion by all means, kill him. Does this bother you? And again, if some big name on TV says: "Pray this prayer with me and you will be saved." Does that bother you. It bothers me because I know that it is not the truth and all who believe it will perish. I care and so I preach against such slander.

Someone might be thinking was the Lord angry at the rich young ruler in Matthew 19:16-22 or Mark 10:17-27. No, because he only wanted to know for himself what he lacked in view or eternal salvation. Also he was not trying to convert anyone else to follow Him. So He truly wanted the answer to his dilemma. So again, he did not go away angry, but sadly they don't like the answer for need to be baptized, for the remission of their sins, or the commandments regarding true worship. These might make them angry, but it won't change God's mind.

Again, a story in Acts 13:4-14 it is revealed the state of righteous anger from the apostle Paul. One Elymas, a sorcerer, tried to turn away the deputy of the country from hearing the gospel.

This angered Paul to the extent that he called him publicly, you deceitful and mischieveousness, you child of the devil, you enemy of all righteousness. Again was our Lord angry in Matthew 23:1-15. Here he openly condemned the foolish ways of the Pharisees, condemning this claiming of being pure and holy, letting men call them father. This Jesus condemned but the worst statement he used in condemning them was, "You by your actions and teachings are shutting up the kingdom of heaven, saying you are not going in yourselves, and those who will follow you will not go in either."

But he didn't cease in condemning their practice of evangelizing. He said, woe unto you scribes and pharisees. You will trouble our lands and seas to make one convert. You will go on to say at length feeding the hungry, building orphanages, hospitals, anything to get him into the fold. But what do you have after you have gotten him in? 

Albert Loren Rhoton, Jr. M.D. age 83, of Gainesville, Florida; passed away Sunday, February 21, 2016 at his

He was born November 8, 1932 in Parvin, Estill County, Kentucky, to Albert Loren and Hazel Van Cleve Rhoton. He began his life in the poverty stricken Kentucky Appalachians and went on to a lifetime of influential achievements in his field that gained him respect of his peers worldwide He was the R.D. Keene Family Professor of Neurosurgery; Dr. Albert had the honor of meeting two presidents, President Ronald Reagan and President Jimmy Carter. His passion was Micro Neuro Surgical education, mentoring young Neuro Surgeons, exercise and family time.

Dr. Albert L. Rhoton, Jr. attended Washington University School of Medicine, graduating with the highest academic standing in the class of 1959. He completed his neurosurgical training at Washington University and joined the staff of the Mayo Clinic in Rochester, Minnesota in 1965. He became Professor and Chairman of the Department of Neurological Surgery at the University of Florida in 1972. Dr. Rhoton has served as President of the American Association of Neurological Surgeons, the Congress of Neurological Surgeons, the Society of Neurological Surgeons, the North American Skull Base Society, the International Interdisciplinary Congress on Craniofacial and Skull Base Surgery, the Florida Neurosurgical Society, and the International Society for Neurosurgical Technology and Instrument Invention. He served as the Honored Guest of the Congress of Neurological Surgeons in 1993 and was awarded the Cushing Medal of the American Association of Neurological Surgeons in 1998, the high-In 2001, he was awarded the Medal of Honor of the World Federation of Neurosurgical Societies. He has served as the Honored Guest or been elected to Honorary Membership in neurosurgical societies in Africa, Asia, Australia, Europe, and North and South America. He has published more than 300 scientific papers. He recently completed the Millennium Issue of NEUROSURGERY



on the posterior cranial fossa and the 25th Anniversary Issue on the supratentorial area. He has received an Alumni Achievement Award from Washington University School of Medicine and both a Distinguished Faculty Award and a lifetime Achievement Award from the University of Florida. In 1998, the University of Florida completed a Brain Institute which houses the activities of the neurosurgical group and the microsurgical laboratory.
