The Lady Engineers Softball team would gain a #1 seed in the upcoming 56th District Tournament with a double header sweep of Powell County on Thursday night. An unusual Home and Home set of games would be used to make up the weather cancellations. The first game would see Estill travel to Stanton and after that game, the teams would load up their buses and head over to Irvine to finish the doubleheader.

#### Estill 4, Powell 1

The opening game would be a tight affair with Estill holding a slim 1-0 lead into the sixth inning on the strength of a Taylor Wiseman solo homerun. In the top of six, Estill would plate three runs on a Zoe Deaton 2-rbi single and a Haley Bishop sacrifice fly to give themselves some breathing room. The Ladies would give up a single run in the seventh but go on to win this one, 4-1. Sarah Wiseman would smack out two hits including a double while McKeely Muncie, T. Wiseman, Deaton, Abby Winkle, and Bishop would all add hits to the box score. Muncie would twirl a beauty from the mound giving up only 4 hits and striking

#### Estill 12, Powell 1

In the second game back at JL Thomas Field, Estill would use a five run first inning to put this one away early. Muncie would smash a homerun of her own in this one and A. Garrrard would score the only run of the game on an infield popup single and a double in the third inning and Estill would fall 1-0.

#### Estill 6, GRC 0

A warm day on Saturday would see Estill hosting George Rogers Clark and Rockcastle Co. in the Lady Engineer Triangle. Estill would take on GRC in the first game. Seven Lady Engineers would get hits in this one and Muncie would


