## Irvine Police Activity Report

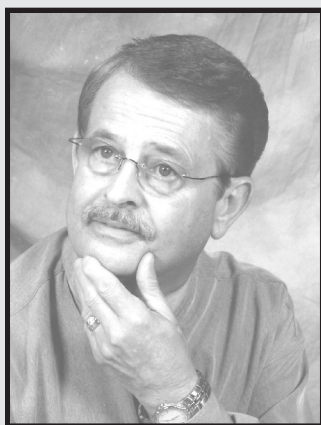
