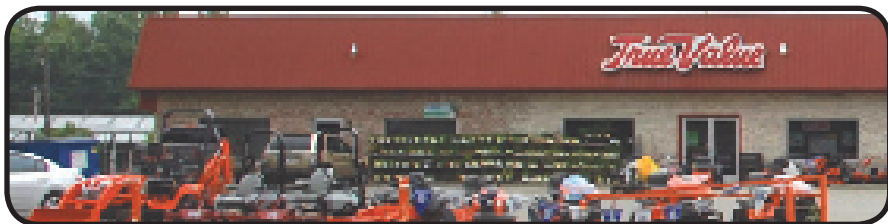

### Rules:

1. Limit of 25 entries per exhibitor.
2. Exhibitor must be present during judging.
3. Entry fee of \$1.00 per exhibit. Pay before the show.
4. Building will not be open to receive poultry until 5:30 P.M. day of the show.
5. All exhibits should be on the grounds by 5:30 P.M.; checked in by 6:30 P.M.
6. Show will begin at 6:30 P.M.
7. There is a limit of 2 entries per owner per class.
8. Any color or variety of 10 or more, according to advance entry, will be divided into a separate class.
9. No exhibit may be entered in more than one class (except Costume Class, Best Pair and Showmanship).  
Divisions:
  - A. Youth Classes will be combined (No Jr. or Sr. Divisions)
  - B. Open Classes - Ribbons and prize money - 3 places
10. Show cages in judging area will be furnished.
11. Only judge, show officials and recorder allowed in judging area.
12. Each exhibitor is to stay with his or her entry and is to be responsible for that entry.
13. The Estill County Fair Board or members of the Poultry Committee will not be responsible for any poultry or accident.
14. Any poultry that is sick, infested or unhealthy will be disqualified by the committee or judges.
15. SECTION 8: STATE RULES (302 KAR 20:065) FOR POULTRY
  - (a) General requirements. Poultry shall be individually identified with an official leg or wing band. The official leg or wing band number shall be recorded on a Certificate of Veterinary Inspection which shall accompany poultry when presented for sale or exhibition.
  - (b) Salmonella Pullorum. Sale and exhibition. A negative agglutination test shall be required for all poultry within thirty (30) days prior to the date of sale or within 150 days prior to the date of exhibition. A Certificate of Veterinary Inspection shall accompany poultry when presented for sale and exhibition and shall document the laboratory which conducted the test and the test date.
  - (c) Chicks and hatching eggs shall originate from a flock that satisfies the requirements of KRS 257.400.
16. Anyone may donate trophies, prize money, or gifts to improve the show and buy cages.
17. See the other rules of the fair that apply to all participants.
18. Classes will be divided into male and female.
19. **Judges' rules are final.**

**Class Prize Money:** 1st place \$3; 2nd place \$2; 3rd place \$1.

**Trophyclasses:** Trophies will be awarded to Grand Champion Open Standard, Youth Standard, Youth Bantam, Open Bantam, Novelty and Showmanship.
