1. All contestants must be at least 13 years of age and not more than 21 years of age as of August 1, 2013. This includes anyone assuming visual importance except piano accompanists.
2. This contest is not open to professionals. Professional is defined as anyone who is a union member, has a professional manager, booking agent or whose principal and supporting income is derived from performing.
3. For contestants entered in any vocal category, accompaniment tracks with any background vocals are strictly prohibited. This includes recorded live and/or synthetically produced voices.
4. ANY ACT RUNNING MORE THAN 4 MINUTES WILL BE DISQUALIFIED. An official timekeeper will be present at the State Fair. Timing begins with first word or note and ends with last word or note. This includes bows.
