Rules:

- 1. Limit of 25 entries per exhibitor.
- 2. Exhibitor must be present during judging.
- 3. Entry fee of \$1.00 per exhibit. Pay before the show.
- 4. Building will not be open to receive poultry until 5:30 P.M. day of the show.
- 5. All exhibits should be on the grounds by 5:30 P.M.; checked in by 6:30 P.M.
- 6. Show will begin at 6:30 P.M.
- 7. There is a limit of 2 entries per owner per class.
- 8. Any color or variety of 10 or more, according to advance entry, will be divided into a separate class.
- 9. No exhibit may be entered in more than one class per division (except Costume Class, Best Pair and Showmanship).

Divisions:

- 1. Youth Classes will be combined (No Jr. or Sr. Divisions)
- 2. Open Classes Ribbons and prize money 3 places
- 10. Show cages in judging area will be furnished.
- 11. Only judge, show officials and recorder allowed in judging
- 12. Each exhibitor is to stay with his or her entry and is to be responsible for that entry.
- 13. The Estill County Fair Board or members of the Poultry Committee will not be responsible for any poultry or accident.
- 14. Any poultry that is sick, infested or unhealthy will be disqualified by the committee or judges.
- 15. SECTION 7: STATE RULES (302 KAR 20:065) FOR POULTRY OR FARM-RAISED UPLAND GAME BIRDS
 - (1) General requirements for entry.
 - (a) Birds (4) months or older for exhibition purposes shall meet the requirements established in subsections (2) and (3) of this section.
 - (b) Chicks or hatching eggs for sale shall meet the requirements established in subsections (2) and (3)(b) of this section.
 - (c) Birds moving to an approved slaughter facility or between a commercial company's facilities shall meet the requirements established in

subsection (4) of this section.

- (2) Certificate of Veterinary Inspection.
 - (a) A CVI, Non-NPIP Flock Report, or NPIP Flock Certificate with the flock number shall be required for movement and exhibition.
 - (b) A CVI or Non-NPIP Flock Report shall be valid for the remainder of the ninety (90) day S. pullorum test period for intrastate exhibition. An NPIP certificate shall be valid for one (1) year from the date issued for intrastate exhibition.
 - (c) The official individual identification, leg or wing band shall be recorded on the CVI or Non-NPIP Flock Report.
- (3) Salmonella Pullorum.
 - (a) Birds four (4) months of age or older shall be negative to an official Salmonella pullorum test within ninety (90) days or originate from a NPIP flock. The NPIP flock number or both the test date and the laboratory of test shall be recorded on the CVI.
 - (b) Chicks or hatching eggs shall originate from a flock as required KRS 257.410.
- (4) Other movements.
 - (a) Persons moving commercial poultry between company facilities shall maintain a log book or possess a way bill stating the origination of the birds and intended destination with the flock NPIP number.
 - (b) Persons moving birds directly to slaughter shall provide the name and address for premises of origin.
- 16. Anyone may donate trophies, prize money, or gifts to improve the show and buy cages.
- 17. See the other rules of the fair that apply to all participants.
- 18. Classes will be divided into male and female.
- 19. Judges rules are final.

Class Prize Money: 1st place \$3; 2nd place \$2; 3rd place \$1.

Trophy classes: Trophies will be awarded to Grand Champion Open Standard, Youth Standard, Youth Bantam, Open Bantam, Novelty and Showmanship.
